Sealed proposals for the construction of the Runway 6-24 Improvements, Powell Avenue Relocation (SR 0299) will be received at the Erie Regional Airport Authority (ERAA) office at 4411 West 12th Street, Erie, PA 16505 until **9:00 AM**, local time, **Thursday, May 27, 2010**. Directly thereafter, the sealed proposals will be publicly opened and read aloud at the International Trade Center, 3837 West 20th Street, Erie, PA 16505.

The Erie Regional Airport Authority (ERAA) is proposing an expansion of Runway 6-24 at Tom Ridge Field in Millcreek Township, Pennsylvania. This proposed runway expansion begins at the eastern terminus of Runway 6-24 and extends for 1,920 feet.

Powell Avenue (SR 0299) is a north-south roadway currently located at the eastern edge of the airport property and will be relocated as a result of this expansion. The approximate limits of the relocation are from West 20th street northwardly and eastwardly to Marshall Drive near its intersection with SR 0005 or West 12th Street. The length of the relocation is approximately 5,300 feet. Included as part of this project are drainage conveyance and stormwater management area improvements, traffic control during construction, signage and pavement markings, wetland relocation and construction of an off-site mitigation area, a new dam, utility coordination and relocations including water, sewer, electric, telephone and gas, and removal of obstructions.

The Contract Documents (consisting of the Advertisement, the Proposal, the Agreement, and the Specifications) and the Contract Drawings may be examined at no expense at the office of Weber Murphy Fox, Inc., the Erie Construction Council, 1102 Chestnut Street, Erie, PA 16501, and at the ERAA office between the hours of 9:00 AM and 4:00 PM.

Documents will be ready for pickup on Monday, May 3, 2010 at 9:00 AM.

Any Document holder, upon returning the Documents in good condition within thirty (30) days of the bid date, will be refunded the full amount of his/her deposit.

Parties failing to conform to the above conditions within the prescribed allotted time shall forfeit their deposits as heretofore set forth and shall have no recourse against the Erie Regional Airport Authority for a refund of the Documents deposit.

Each proposal must be accompanied by a certified check or bid bond, in the amount of five percent (5%) of the total maximum proposal price (combination of base bid or alternate bid plus add-on items) for the contract in the form and subject to the conditions provided in the Preparation of Proposal.

A pre-bid conference has been scheduled in order to review the specific requirements of this contract. All prospective bidders are encouraged to attend. The pre-bid conference is scheduled for Tuesday, May 11, 2010 at 10:00 a.m. at the Erie International Trade Center, 3837 West 20th Street, Erie, PA 16505.

The DBE goal for this contract is 16%. Bidders shall be required to participate in the federal affirmative action program, as defined more specifically in the Specifications contained in the Contract Documents. Bidders are also required to comply with a Project Labor Agreement, as set forth more specifically in the Specifications contained in the Contract Documents.

The Erie Regional Airport Authority reserves the right to waive any informality in the proposal, and to reject any and all proposals.
