We first bid this in May but threw out all bids because none were responsive and responsible. The FAA granted ERAA an extension to rebid the project. This resolution is for the rebid. Mr. Martin reported that after technical review by Mead & Hunt and legal review by Jennifer Gornall, Joseph McCormick Construction Co. has been determined to be the lowest responsive and responsible bidder at \$2,747,767.

ERIE REGIONAL AIRPORT AUTHORITY RESOLUTION 2025 - 06

AWARD OF ERIE INTERNATIONAL AIRPORT REALIGNMENT & RECONSTRUCTION OF TAXIWAY A PHASE 4 BID

WHEREAS, the Erie Regional Airport Authority ("ERAA") operates the Erie International Airport and is responsible for the continued maintenance and upkeep of the taxiways at Erie International Airport; and

WHEREAS, the ERAA has determined that the Erie International Airport Taxiway A is in need of realignment and reconstruction; and

WHEREAS, the ERAA has publicly solicited bids from interested firms for the realignment and reconstruction of Taxiway A (Phase 4)("the Project"); and

WHEREAS, ERAA publicly opened the two (2) bids received and reviewed the bids to determine (a) whether each bidder was a "responsible" bidder and (b) whether each bid was responsive to the bid specifications; and

WHEREAS, the bid submitted by Joseph McCormick Construction Co., Inc. was the lowest bid and was responsive to the ERAA's bid specifications and, therefore, the Administration recommends that the realignment and reconstruction of Taxiway A (Phase 4) bid be awarded to Joseph McCormick Construction Co., Inc.; and

WHEREAS, the ERAA's engineer and Solicitor have performed a due diligence review of the bids submitted and they concur that Joseph McCormick Construction Co., Inc. is the lowest responsible and responsive bidder for the Project.

AND NOW, THEREFORE, on this 19th day of June, 2025, it is hereby RESOLVED by the Board of Directors of the Erie Regional Airport Authority, the following:

- 1. Joseph McCormick Construction Co., Inc. is declared to be the lowest responsible and responsive bidder for the Project, in the amount of Two Million Seven Hundred Forty Seven Thousand and Seven Hundred Sixty Seven Dollars (\$2,747,767.00).
- 2. The Board authorizes the Executive Director to execute the contract documents and proceed in all ways necessary with the award of the bid to and the execution of the contract with the lowest responsible and responsive bidder, Joseph McCormick Construction Co., Inc.
