### **New Business**

Chris Rodgers asked for direction regarding our National Fuel rate. He explained that we have the opportunity right now to lock in at a rate lower than we are paying now for 1 or 2 years OR we can go with a variable rate. Ms. Bruno said that we have the option to shop around for another supplier.

Mr. Stefano said that we need to be careful about our supplier. We need to be confident that the supplier can supply what we need. Locking in to a 1 year contract with National Fuel may work best for us. Ms. Bruno provided the rates for comparison.

Mr. Rodgers said that it is staff's recommendation to lock in a rate with National Fuel for 1 or 2 years. Mr. Stefano agreed that 1 year would be best.
